Hiking + officers serve a 1-year term starting in January (except for the Winter Chairperson who starts in April). According to ERC rules, the officers elected for President and Treasurer must be JPL employees. Other offices may be held by JPL employees/Contractors. Caltech and off-lab members, though not eligible to be officers, may vote, nominate, and serve on committees.

BRIEF SUMMARY OF THE OFFICERS' RESPONSIBILITIES:

PRESIDENT: Formulates/proposes policy, runs meetings, coordinate outside activities.

1st VP/SUMMER CHAIRPERSON: Plans summer programs, conducts trip planning meetings, chooses trip leaders, maintains trip leader report files, maintains electronic copies of flyers, distributes flyers for activities for the summer schedule, and publicizes future and past trips.

2nd VP/WINTER CHAIRPERSON: Plans winter schedule, conducts trip planning meetings, chooses trip leaders, maintains trip leader report files, maintains electronic copies of flyers, distributes flyers for activities for the winter schedule, and publicizes future and past trips.

SECRETARY: Maintains membership list and records, prepares and processes correspondence as required, updates and maintains the Hiking+'s WWW site, posts Hiking + events on the JPL forum newsgroup, and provides Hiking + activity information to JPL Universe.

TREASURER: Handles Hiking + funds and reports financial status to the Hiking + officers, prepares annual ERC budget package.

SPECIAL EVENTS COORDINATOR: Schedules presenters and hosts noon time slide shows, arranges for special presentations, equipment demos, and training, rewards slide show presenters with lunch, Hiking + T-shirt, or other incentives.

NOTE: The officers do not have to do all the work themselves, and may form committees of volunteers to assist them. To facilitate the election process, you have, on this form the perfect opportunity to volunteer yourself to lead the committee of your choice. This is your chance to contribute and support the Hiking+. **YOU MAY NOMINATE YOURSELF; YOU MAY NOMINATE A PERSON FOR MORE THAN ONE OFFICE.**
